Exceptionally, in the event that ***the REMIT Data And Reporting Services Agreement*** (hereinafter: the Agreement) is terminated in the course of a calendar year, CROPEX will issue an invoice for the fees for the calendar year in which the Agreement ceased as soon as all information for calculation of fees become known, and the Member is obliged to settle the claim arising from the respective invoice within the due date as indicated in the invoice.
